This product is created by combining refined lamprey oil extracted from natural lamprey and vitamin A oil. It is a medicament that provides vitamin A replenishment during pregnancy and while nursing, for dry eyes, loss of stamina during and after an illness and during a person's growth period.



【Precautions】



Consultation

- 1、 The following persons should contact a physician, pharmacist, or registered salesperson for a consultation before administration.
 - (1) Those who are receiving medical treatment.
 - (2) Pregnant women in not more than 3 months of gestation, women who think they may be pregnant or who wish to become pregnant. (There are reports documenting that the incidence of congenital anomalies in newborns increased with pregnant women who had taken 10,000 IU/day or more of vitamin A within 3 months before the pregnancy until 3-month gestation.)
- 2、 If the following symptoms are observed after taking this drug, these may be adverse reactions, so immediately discontinue the use of this drug, and show this document to your physician, pharmacist, or registered salesperson for a consultation.

- 3、 If your symptoms do not improve after 1 month of taking this product, please take this text and enquire with your physician, pharmacist or registered salesperson.

【Indications】

Provides relief for the following symptoms: dry eyes, night-blindness.

Vitamin A replenishment in the following cases:

During pregnancy and while nursing, loss of stamina during and after an illness and during a person's growth period.

【Ingredients】

6 capsules (daily dose for an adult) contain the following ingredients.

Ingredients	Quantities 6 capsules
Purified Lamprey contained oil	495.0mg
Vitamin A oil (30,000 IU/g)	0.9mg

Inactive ingredients : soybean oil, concentrated glycerin and p-hydroxybenzoate esters.

【Dosage and administration】

Age	Single Dose	Doses per day
Adult (15 years old and over)	2 capsules	3times/day after meals
Over 5 years of age and under 15 years	1 capsule	3times/day after meals
Children (under 5 years old)	Please do not take it.	

【Precautions regarding dosage and directions】

- (1) You must follow the usage and dosage directions.
- (2) When allowing children to take the medicine, a guardian must be present to watch and tell such them how to take it.
- (3) Do not give this medication to children under 5.

【Cautions for storing and handling】

- (1) Keep away from high temperature, avoid high humidity and direct sunlight, store in a cool, dry place. (Do not keep in the refrigerator)
- (2) Keep it away from the reach of children.
- (3) The plastic bag with a zipper containing the product has been specially treated. To maintain the stability of the product's quality, do not keep in other containers.
- (4) After opening, please consume the product as early as possible.
- (5) Do not use any expired product.
